

Regulations of the Drap-Art Market for recycling art and sustainable consumption at Plaza Real

RIGHTS AND OBLIGATIONS OF THE DRAP-ART ASSOCIATION

- 1) The association as such has the right to select the exhibitors participating in the market.
- 2) The association can also choose substitutes for the stall-holders who, for justified reasons, do not attend the day of the celebration.
- 3) The exhibition spaces in the market are allocated for the whole year.
- 4) If any of the selected holders cannot assist on a determined day, Drap-Art undertakes to look for a substitute if the absence is notified at least one week in advance of the Saturday of the leave if the cause is a *force majeure*, like an illness or an accident. Planned absences, because the stall-holder wants to do another fair or has to travel or attend some other business, should be notified on the application form or at least 2 months in advance. In any case if the organizers cannot find a substitute, the stall-holder will be responsible for paying the day he/she was absent anyway.
- 5) On notification, Drap-Art will look for substitutes. If there are several notified absences, they will be covered in order of notification. If there are no substitutes or not enough to cover all the absences, the stalls that are not covered will have to be paid equally by the stall-holders
- 6) Drap-Art may deny assistance to the market to a participant who is not up to date with the payment of the stall or whose products do not match those initially presented or because he/she does not respect the regulations.
- 7) Drap-Art may request a deposit for the loan of cloths with the logo and other promotional material delivered. Deposit that will be recovered when these are returned, provided they are in good condition.
- 8) The Association has the obligation to hold an annual assembly, with the participation of the associates and participants of the market.
- 9) The Association will be in charge of requesting the licenses for the market from Barcelona City Council, after collecting the necessary documents provided by the participants.
- 10) The Association is obliged to have civil liability insurance for the entire market.
- 11) The Association must send the location map of the stalls at least 24 hours in advance.
- 12) The Association must provide a person, responsible for receiving and serving the exhibitors during assembly and disassembly of the market.

RIGHTS AND OBLIGATIONS OF MARKET PARTICIPANTS

- 1) Only members who are up to date with their payments to the Association (annual membership fee of €35 and market payments) will have the right to participate.
- 2) Those who unsubscribe once the season has started will not be entitled to a refund of the fees paid.
- 3) Only those who have submitted the documentation requested for the market call and that have been selected as license-holders, will participate on a regular basis.
- 4) Stall-holders must arrive at 9am in the morning to mount and have finished dismounting at 11pm. At 11pm the square must be empty.
- 5) The schedule established by the urban guard must be respected: You can enter by car and park until 11am in the morning, according to City Council regulations. At night there are no regulations that allow the entry of cars. As the City Council and the Urban Police understand that the market items have to be recollected, they let us access by car, exceptionally. You must enter after 9pm, only to pick up your things, without lingering more than is absolutely necessary.
- 6) Stall-holders will collect and dispose of the garbage generated during the day, leaving the square clean and diaphanous as they have found it in the morning.
- 7) Stall-holders can only sell the items presented in the call; any variation will have to be consulted. Otherwise, Drap-Art will have the right to withdraw these products.
- 8) Only items created with recycled materials will be accepted.

- 9) The tents will be located according to the marks on the ground and the plan sent by the Association.
- 10) It is essential to have a 2 x 3m² white cloth tent and a table of max. 2m long, by a width of 0.80m or 1m. Drap-Art has a tent that it rents for €20/day during max 4 weeks to exhibitors who are starting out and want to try out the market before making the investment to buy their own tent. - 11) Autonomous lights (which do not need to be plugged into an electrical source that we do not have) and with sufficient intensity to illuminate the stall.
- 12) The colors of the market are black and white. The cloths provided by the association are black and the other fabrics or decorative elements that are to be used to decorate the stall must be white (or black).
- 13) The tables and furniture that are part of the decoration and assembly of the stall cannot protrude from the space formed by the tent.
- 14) The placement of promotional materials is mandatory once the tent is set up and **before** putting the merchandise on display.
- 15) The consumption of narcotic substances and alcohol is prohibited at the stalls.
- 16) The fees of €50 / day for a full stall (€30 / day for a half stall) will be paid monthly in advance into the Drap-Art account:

- 17) The licenses are nominal and the receipts for each license will be paid by the corresponding stall-holder, in addition to the monthly fees.

EXHIBITORS WHO WANT TO SHARE A STALL

- 1) They must provide their own tent, table and lights and alternate their use with the use of the tent of the stall-holder with whom they share. If they do not have a tent, they must pay €10 / day as compensation for the use of the tent of the other stall-holder or reach another agreement. If none of them has a tent, they must rent it from Drap-Art and pay 10€ / each.
- 2) Likewise, they must agree to decide who will occupy the 2m side of the tent and who will occupy the 3m side. If there is no other agreement, it will be alternately.
- 3) The exhibition elements, like tables or clotheshangers must leave a prudent space to enter and leave the stall. The exhibitor occupying the 3m side must leave a 1m space to be able to enter and exit the tent.
