

## Regulations of the Drap-Art Market for Artistic Recycling and Sustainable Consumption at Plaza Real 2025

## **RIGHTS AND OBLIGATIONS OF THE DRAP-ART ASSOCIATION**

- 1. The association has the right to select the exhibitors participating in the market.
- 2. It may also choose substitutes for the main exhibitors who, for justified reasons, cannot attend on the day of the market.
- 3. The exhibition spaces at the market are allocated for the entire year.
- 4. If any of the selected main exhibitors withdraws, Drap-Art commits to finding a substitute, provided the withdrawal is notified one week before the Saturday of the absence, if it is due to force majeure, such as illness or an accident. Planned absences, such as attending another market, a trip, or a business commitment, must be notified in the registration form or at least 2 months in advance. In any case, if the organizer does not find a substitute, the exhibitor must still pay the fee for the day of absence.
- 5. At the time of notification of the withdrawal, Drap-Art will seek substitutes. If there are multiple withdrawals, they will be covered in the order of notification. If there are no substitutes or not enough to cover all withdrawals, the uncovered withdrawals must still be paid.
- 6. The association may deny market participation to any exhibitor who is not up to date with their stall payments, who brings products that do not match those initially presented, or who does not comply with the regulations.
- 7. A deposit may be requested for the loan of logo skirts and other promotional materials provided. The deposit will be returned when these materials are returned, provided they are in good condition.
- 8. The Association is obliged to hold an annual assembly with the participation of its members.
- 9. The Association will be responsible for applying for the market licenses from the Barcelona City Council, after collecting the necessary documents provided by the participants.
- 10. The Association is required to have liability insurance for the entire market.
- 11. The Association must send the stall layout plan at least 24 hours in advance.
- 12. The Association must provide a person responsible for receiving and assisting exhibitors during setup and dismantling.



## **RIGHTS AND OBLIGATIONS OF THE MARKET PARTICIPANTS**

- 1. Only members who are up to date with their payments to the Association (annual membership fee and market payments) will have the right to participate.
- 2. Those who withdraw once the season has started will not be entitled to a refund of the fees paid.
- 3. Regular participation will be granted to those who have submitted the required documentation for the market call and have been selected as main exhibitors.
- 4. Main exhibitors must show active commitment to the market. Frequent last-minute absences, especially during months with many withdrawals (July, August, and December), may affect the renewal of their license.
- 5. Participants must arrive at 9:00 AM to set up and must finish dismantling by 11:00 PM. By 11:00 PM, the square must be empty.
- 6. The schedule established by the Urban Guard must be respected: Cars may enter and park until 11:00 AM, according to City Council regulations. At night, there are no regulations allowing cars to enter. Since the City Council and the Urban Police understand that the market must be cleared, they exceptionally allow us to enter. Cars may enter from 9:00 PM only to collect items, without parking longer than absolutely necessary.
- 7. Exhibitors must collect any waste generated during the day and leave the square clean and clear as they found it in the morning.
- 8. Only items made from recycled and sustainable materials will be accepted.
- 9. Tents must be set up according to the markings on the ground and the plan sent by the Association.
- 10. It is essential to have a  $2 \times 3m^2$  white fabric tent and a table with a maximum length of 2m and a width of 0.80m or 1m.
- For new substitutes who do not yet have a 2 x 3m white tent, Drap-Art can provide one at an additional cost of €20/day for tent use during the first 2 months. We recommend tents from <u>https://viada.net</u> or <u>www.regalosmiguel.com</u>.
- 12. Autonomous lights with sufficient intensity for stall lighting, which do not need to be plugged into the electrical grid, as we do not have access to it.
- 13. Tables and furniture that are part of the stall decoration and setup must not extend beyond the space formed by the tent.
- 14. Promotional materials must be placed once the tent is set up and before displaying the merchandise.
- 15. The consumption of narcotics and alcohol in the stalls is prohibited.
- 16. Main exhibitors will pay a daily fee of €40, which will be paid monthly before the 1st of the month to be paid.
- 17. The payment of nominal licenses will be the responsibility of each main exhibitor, in addition to the monthly fees.
- 18. Substitutes who do not have to bear the cost of the license will pay €50 per day.

## PEOPLE REQUESTING TO SHARE A STALL

- 1. The Barcelona City Council does not anticipate that a stall will be shared, so licenses are issued in the name of a single main exhibitor. Main exhibitors who wish to share their stall may do so with a non-main exhibitor, but if they wish to share the license cost, they must find a substitute exhibitor willing to share the stall for the entire season or assume the cost entirely.
- 2. The price for a shared tent for substitutes is  $\in$  30 per day.
- 3. If neither of the substitutes has a tent, Drap-Art can provide one for the first 2 months until they acquire their own, at an additional cost of €20/day for tent use (€10 each). If one of the two has a tent, the one who does not will pay an additional €10 (€40 instead of €30) as compensation for tent use, and the exhibitor providing the tent will pay €20 instead of €30.
- 4. If both have tents, they must agree on who will set up the tent.
- 5. They must also agree on who will occupy the 2m side of the tent and who will occupy the 3m side. If no other agreement is reached, it will be done alternately, one week one person and the next week the other.
- 6. The setup of the elements must leave a reasonable space for entering and exiting the stall. The exhibitor occupying the 3m side must leave a 1m passage to enter and exit the tent.
